On June 30, 2010, the Reporting Person's beneficial ownership of 1,141,638 of these shares changed from direct to indirect when beneficial ownership of such shares was transferred from the Reporting Person to Madison Investors Corporation ("MIC"), which is an indirect wholly owned subsidiary of the Reporting Person. Also on June 30, 2010, beneficial ownership of 196,053 of these shares was transferred from Madison National Life Insurance Company, Inc. ("MNL"), which is an indirect wholly owned subsidiary of the Reporting Person, to MIC. The remaining 2,926,810 of these shares are also beneficially owned by MIC.
