- (2) Each subordinated unit will convert into one common unit at the end of the subordination period, which will end if the Issuer has earned and paid at \$1.25 on each outstanding common unit and general partner unit for any three consecutive, non-overlapping four-quarter periods ending on or after the date specified in the partnership agreement, but may end sooner if the Issuer meets additional financial tests as described in the partnership agreement. The subordinated units have no expiration date.
