Item 1.01 Entry into a Material Definitive Agreement.

On February 12, 2008, the Board of Directors of Old Point Financial Corporation approved the 2008 target bonuses and performance goals for the Company s named executive officers under the Company s Executive Incentive Plan as recommended by the Compensation Committee.

Short-Term Cash Incentive Awards. The 2008 performance targets are based on the Bank's average asset growth (weighting: 10%), the loan growth (weighting: 10%), the Bank's average deposit growth (weighting: 10%), the Trust Company's revenue growth (weighting: 10%), the Company's earnings growth (weighting: 40%) and a subjective component related to nonfinancial goals as determined by the board (weighting: 20%). Depending on the company's 2008 performance with respect to these measures, the Company's named executive officers, among others, may earn a short-term cash incentive award for 2008 in a range from 0% to 28% of their 2008 annualized based salary, subject to adjustment in the discretion of certain officers of the Company.
