Ownership

(a) Amount beneficially owned Lakeview Investment Group is the sole general partner of Lakeview Fund, L.P., a Delaware limited partnership (Lakeview Fund), and the sole investment manager of Lakeview Master Fund, LTD, a Cayman Islands exempted company (Master Fund). Mr. Levy is the majority owner and sole manager of Lakeview Investment Group.

As of December 31, 2011, the Reporting Persons beneficial ownership were as follows: (i) Lakeview Investment Group beneficially owned 250,863 Shares, consisting of 227,383 Shares held by the Master Fund and 23,480 Shares held by the Lakeview Fund; and (ii) Mr. Levy, as the sole manager of Lakeview Investment Group, beneficially owned the 250,863 Shares beneficially owned by Lakeview Investment Group.

The Reporting Persons have, within the ordinary course of business, purchased securities of the Company. The Reporting Persons have not acquired securities in the Company with the purpose, nor with the effect of changing or influencing the control of the issuer, nor in connection with or as a participant in any transaction having such purpose or effect. The Reporting Persons have purchased, and may in the future purchase, shares on the open market at prevailing prices.

- (b) Percent of class As of December 31, 2011, the Reporting Persons beneficial ownership, based on 14,012,896 shares of Issuer Common Stock outstanding as of January 9, 2012, as disclosed by the Company in its Quarterly Report on Form 10-Q filed with the SEC on January 12, 2012, were as follows: (i) Lakeview Investment Group beneficially owned 1.79% of the outstanding Issuer Common Stock and (ii) Mr. Levy beneficially owned 1.79% of the outstanding Issuer Common Stock.
