- Pursuant to the Endo Pharmaceuticals Directors Stock Election Plan, on December 16, 2008, Mr. Spengler elected to receive 100% of his 2009 cash retainer fees in Endo common stock. At the time that the retainer fees would otherwise have been payable, the number of (1) shares of Endo common stock are fixed and are reported as of such date on Table I as an acquisition of securities. These cash retainer fees are payable to Mr. Spengler in consideration of his services on the Endo Pharmaceuticals Holdings Inc. Board of Directors, and the amount reported on this Form represents Mr. Spengler's third quarter 2009 retainer fees.
