- (1) Between November 23, 2006 and December 14, 2006, the Reporting Person acquired 77 shares of the Company's common stock through dividend reinvestment and 113 shares through the Company's Employee Stock Purchase Plan.
- (2) Between November 23, 2006 and December 14, 2006, the Reporting Person acquired 53 shares of DRE's common stock under the Company's 401(k) plan.
