Item 1.01. Entry into a Material Definitive Agreement.

On October 16, 2013, a subsidiary of Blueknight Energy Partners, L.P. (the "Partnership") and Vitol Inc. entered into second amendments (the "Amendments") to two Crude Oil Storage Services Agreements with Vitol Inc. ("Vitol"). Fifty percent of the membership interests of Blueknight Energy Partners G.P., L.L.C., the general partner of the Partnership, are indirectly owned by Blueknight Energy Holding, Inc. ("Blueknight Holding"). Blueknight Holding and Vitol are affiliated entities as both companies are indirectly owned by Vitol Holding B.V.

The Amendments extend the term of the agreements, which were scheduled to expire on October 31, 2013 (the "Storage Agreements"), through March 31, 2014 and, effective as of November 1, 2013, adjust the rates Vitol is charged for services provided under the amended agreements. Revenues earned under the Storage Agreements are based upon the 0.5 million barrels of storage capacity that is dedicated to Vitol under each agreement.

The foregoing description is a summary of the Amendments and is qualified in its entirety by reference to the Amendments, copies of which are included as Exhibits 10.1 and 10.2 to this Form 8-K.
