The Company required additional time to complete review procedures with respect to the Company's accounting for deferred income taxes and the related impact on the effectiveness of our internal control over financial reporting. The Company has concluded these review procedures and is filing the Quarterly Report on Form 10-Q for the period ended June 30, 2018 simultaneously with this extension under Rule 12b-25(b) under the Securities Exchange Act of 1934, as amended.

Additionally, the Company expects to report that gross profit increased 9.3% to \$24.6 million, representing a 27.7% gross margin, compared to \$22.5 million, representing a 27.8% gross margin, in the prior year quarter.
