The following constitutes Amendment #2 to the Schedule 13D filed by the undersigned(the "Schedule 13D").

Item 3. Source and Amount of Funds or Other Consideration.

The aggregate purchase price of the 1,591,600 Shares of Common Stock owned beneficially by JANA Partners LLC is \$7,081,836. Such Shares of Common Stock were acquired with investment funds in accounts under management.

Item 5. Interest in Securities of the Issuer.

(a) The aggregate percentage of Shares of Common Stock reported owned beneficially by the Reporting Person is based upon 16,186,373 Shares outstanding, which is the total number of Shares of Common Stock outstanding as reported in the Issuer's Quarterly Report on Form 10-Q for the quarter ended September 30, 2002.

As of the close of business on January 30, 2002, JANA Partners LLC beneficially owned 1,591,600 Shares of Common Stock, constituting approximately 9.8% of the Shares outstanding.

(b) The Reporting Person has sole voting and dispositive powers with respect to the Shares reported herein, which powers are exercised by the Principals. All of such Shares were acquired in open-market transactions.

(c) Schedule A annexed hereto lists all transactions in the Issuer's Common Stock in the last sixty days by the Reporting Person.

(d) No person other than the Reporting Person is known to have the right to receive, or the power to direct the receipt of dividends from, or proceeds from the sale of, such Shares of the Common Stock.
