The following constitutes Amendment No. 2 ("Amendment No. 2") to the Schedule 13D filed by the undersigned. This Amendment No. 2 amends the Schedule 13D as specifically set forth.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 is hereby amended and restated to read as follows:

The aggregate purchase price of the 115,928 Shares beneficially owned by WILLC is approximately \$1,380,849. The Shares beneficially owned by WILLC consist of 289 Shares that were acquired with WILLC's working capital, 72,665 Shares that were acquired with WIHP's working capital and 42,974 Shares that were acquired with WITRP's working capital.

The aggregate purchase price of the 47,879 Shares beneficially owned by BPM is approximately \$506,440. The Shares beneficially owned by BPM consist of 36,842 Shares that were acquired with BPIP's working capital and 11,037 Shares that were acquired with BPP's working capital.

Item 5. Interest in Securities of the Issuer.

Item 5(a) is hereby amended and restated to read as follows:

(a) The aggregate percentage of Shares reported owned by each person named herein is based upon 5,023,997 Shares outstanding, which is the total number of Shares outstanding as of June 5, 2009, as reported in Exhibit 99.2 to Amendment No. 3 to the Issuer's Tender Offer Statement on Schedule TO filed with the Securities and Exchange Commission on June 5, 2009.

As of the close of business on June 9, 2009, WIHP and WITRP beneficially owned 72,665 and 42,974 Shares, respectively, representing approximately 1.4% and less than 1%, respectively, of the Shares outstanding. As of the close of business on June 9, 2009, WITRL did not own any Shares. As the general partner of each of WIHP and WITRP, WILLC may be deemed to beneficially own the 115,639 Shares owned in the aggregate by WIHP and WITRP, representing approximately 2.3% of the Shares outstanding, in addition to the 289 Shares it holds directly. As the managing member of WILLC, Mr. Lipson may be deemed to beneficially own the 115,928 Shares beneficially owned by WILLC, representing approximately 2.3% of the Shares outstanding. As members of a group for the purposes of Rule 13d-5(b)(1) of the Securities Exchange Act of 1934, as amended, the Western Entities may be deemed to beneficially own the 47,879 Shares owned by the other Reporting Persons. The Western Entities disclaim beneficial ownership of such Shares.

As of the close of business on June 9, 2009, BPIP and BPP beneficially owned 36,842 and 11,037 Shares, respectively, representing less than 1% and less than 1%, respectively, of the Shares outstanding. As the managing member of each of BPIP and BPP, BPM may be deemed to beneficially own the 47,879 Shares owned in the aggregate by BPIP and BPP, representing less than 1% of the Shares outstanding. As managing members of BPM, Messrs. Franzblau and Ferguson may be deemed to beneficially own the 47,879 Shares beneficially owned by BPM, representing less than 1% of the Shares outstanding. As members of a group for the purposes of Rule 13d-5(b)(1) of the Securities Exchange Act of 1934, as amended, the Benchmark Entities may be deemed to beneficially own the 115,928 Shares owned by the other Reporting Persons. The Benchmark Entities disclaim beneficial ownership of such Shares.
