The Company on the other hand confirms that the activities aimed at the definition of the Group's 2014-2016 industrial plan are ongoing and that the industrial Plan will be presented to the Board of Directors on November 7th.

8. the impact of regulatory decisions and changes in the regulatory environment in Italy and other countries in which we operate, including recent changes to allowable charges for data and voice roaming;
