First Interstate Bank has sole voting power for 268,414 shares, including 267,966 shares held as trustee for various Scott family members and 448 shares held in trust for others.

First Interstate Bank has sole dispositive power for 389,784 shares, including 387,138 shares held as trustee for various Scott family members and 2,646 shares held in trust for others.

First Interstate Bank has shared voting power for 670,595 shares, including 554,080 shares held as trustee for the Savings and Profit Sharing Plan of First Interstate BancSystem, Inc., 99,919 shares held as trustee for various Scott family members and 16,596 shares held in trust for others.

First Interstate Bank has shared dispositive power for 846,646 shares, including 554,080 shares held as trustee for the Savings and Profit Sharing Plan of First Interstate BancSystem, Inc., 274,947 shares held as trustee for various Scott family members and 17,619 shares held in trust for others.

First Interstate Bank has no voting power for 297,421 shares, including 294,200 shares held as trustee for various Scott family members and 3,221 shares held in trust for others.
