This Amendment No. 1 amends the Schedule 13D filed by Richard L. Scott (Reporting Person) on July 10, 2008 (the Schedule 13D), with respect to shares of the Common Stock, \$.01 par value (Common Stock), of Wireless Telecom Group, Inc., a New Jersey corporation (the Issuer). Capitalized terms used but not defined herein shall have the respective meanings ascribed to such terms in the Schedule 13D.

The following Items are hereby amended and restated in their entirety to read as follows:

Item 3. Source and Amount of Funds or Other Consideration

The Reporting Person has used personal funds of approximately \$2,326,886 to acquire 1,578,595 shares of Common Stock in open market transactions. The Common Stock was purchased by three different entities controlled by the Reporting Person.

Item 5. Interest in Securities of the Issuer

The 1,578,595 shares of the Common Stock owned by the Reporting Person constitute 6.15% of the outstanding Common Stock of the Issuer, based on the outstanding shares of Issuer Common Stock set forth on the Issuer's most recent Form 10-Q.

The Reporting Person has sole voting and dispositive power with respect to the Common Stock.
